MASS MARRIAGE CEREMONY ONCE AGAIN

The RP Foundation is in the process of conducting the Mass Marriage ceremony for the second time in Kollam. Christened, 'Samooha Parinayam-2013', the project aims at fulfilling the marriage dreams of all bridal girls who hail from economically backward families, irrespective of caste or creed.

Apart from coming from poor families, the brides and grooms, who are eligible for marriage under the Indian Marriages Act and whose marriages were duly decided and fixed jointly by both the families can apply. The marriages of the selected couples will be conducted in a grand function to be held in August/September next year in a specially built venue (Pandhal) in the vicinity of dignitaries. The Foundation will bear all the wedding expenses and will also provide clothes in addition to a gift of Rs. 1.5 as Cash to each couple. Further those aspiring for a job will also be given suitable placements in the various establishments of the RP Group both in India and abroad based on qualifications.

Those wanting to participate in 'Samooha Parinayam-2013' should apply in the prescribed application with all relevant details and documents to: The Convenor, RP Foundation, III Floor, Ravi's Arcade, Near Iron Bridge, Kollam – 691 001.

The selection process will be done through a thorough scrutiny with candid criteria and in strict accordance with norms prescribed in the guidelines and every care will be taken to ensure that the benefit goes only to the most deserving. The RP Foundation hopes that the State of Kerala will proudly accept this noble objective and would extend supportive hands towards its culmination.

GUIDELINES

The applicant should essentially be the bride. The selection criteria is based on the financial status of the bride's family. Applications can also be submitted for inter-caste marriages. The fully completed applications should be submitted with all necessary certificates/documents.

ELIGIBILITY CRITERIA:

- 1. Matured, un-married Keralite girls hailing from financially poor families from any district in the State are eligible
- 2. The applicant and her family should be from the Below Poverty Line (Income Certificate to be produced)

PREFERENCES:

- 1. Preference will be given to applicants whose parents are not alive and who do not have matured brothers
- 2. Applicants whose father has expired and who doesn't have any matured brothers
- 3. Applicants whose parents are unable to find out a living because of incurable / perennial diseases.
- 4. Applicants whose parents are suffering from physical / mental disorders.
- 5. Applicants whose mother has expired.
- 6. Daughters of alive parents, who are unable to get married because of financial difficulties in the family.
- 7. Matured Girls who doesn't come under any of the above categories, but who hail from financially backward families

CERTIFICATES / DOCUMENTS TO BE SUBMITTED:

- 1. Income Certificate
- Proof of age (SSLC Book or Birth Certificate)
- 3. Death certificate, if Father or Mother has expired
- 4. Medical certificate, if parents are suffering from incurable / perennial diseases
- 5. Medical certificate, if parents have physical / mental disorders
- 6. Copy of Ration Card
- 7. Certificate from the respective Community Organization if the marriage has been decided abiding to communal /caste norms
- 8. Affidavit, attested by a Gazetted Officer is to be submitted by the bride and bridegroom regarding fixation of marriage, if this is an inter caste marriage
- 9. Divorce documents of the bridegroom related to the first marriage, if this is the second marriage
